It is also designed to explain what is expected by the Gompa Lhasa Apso Preservation Program (the "Program") from you and the dog. I/We hereby make application to the Gompa Lhasa Apso Preservation Program. I/We agree to have my/our name(s) added to the waiting list for the purpose of giving a Gompa Lhasa Apso a permanent home. I/We understand there is a donation to defray the cost of the Program). I/We understand that when I/We receive the Apso it will:

I/We understand that the Program may place with me a puppy that may not be contributing genetically to the lineage. In this instance, the Program will determine when the puppy can be spayed or neutered. I/We agree to follow the instructions of the Program in this regard and will provide written proof of said puppy's spay/neuter. I/We also understand said puppy will be routinely tracked under the guidelines of the Program.

I/We understand that the Lhasa may not be spayed, neutered, sold or otherwise given by myself/ourselves to any other person or organization without written permission from the Program.

I/We will have an identification tag on the animal at all times with our current address and phone number. Further, by giving the Gompa Lhasa Apso a permanent home, I/We accept full responsibility for the care of the Apso and agree to:

- a) In the event I/We accept a Gompa Lhasa Apso and for any reason can no longer care for or keep the dog, we agree to immediately **return** the dog to the Program. If this occurs, I/We will sign the necessary papers for the surrender of the Gompa Lhasa Apso.
- b) Notify the Program within 24 hours in case the dog is lost or stolen and make every effort to locate the Apso.
- c) Never take this dog to an animal shelter for the purpose of surrender.
- d) Never abuse, hit, or mistreat this animal.
- e) Properly house, feed, water and care for this Gompa Lhasa Apso.
- f) Exercise proper control and restraint over this dog at all times and not permit this dog to run at large.
- g) Comply with all state and local ordinances relating to the keeping of this dog, including leash and license laws.
- h) Not use this animal for any type of experimental or breeding purpose outside the confines of the Program.
- i) Provide regular veterinary care, including appropriate vaccinations, parasite checks, dental care and regular grooming.
- j) Provide exercise, adequate companionship and love.
- k) Not leave dog alone outside unattended at any time.
- l) Ensure this Lhasa is maintained as an inside dog. I/We agree to keep the dog inside the house when no one is at home, and agree that the dog will sleep inside the house at night.
- m) Keep the Program informed of our current address should we move residence, whether in-state, out-of-state, or out-of-country. If we must move out of the area and we find we are for any reason unable to keep this Gompa Lhasa Apso, we will immediately contact the Program and work with said group to find an appropriate home for the dog.
- n) Never abandon this Gompa Lhasa Apso.
- o) Allow representatives of the Program to periodically check on the dog to assure compliance with these items listed (a through n).

I/We have read the foregoing and agree with all the provisions and stipulations stated herein. The Program reserves the right to refuse any applicant. If the above statements are found to be fraudulent or untrue: **We reserve the right to repossess the Gompa Lhasa Apso and all liabilities are waived. This is a binding contract, enforceable by civil law.**
